

ny of the Discovery Channel and The Learning Channel. Hudson operates othernon-newsstand stores including Hudson Booksellers, Kids Works and Crabtree & Evelyn.

But the secret to the company's success has been focusing on "our two primary businesses, which is the wholesale magazine business and the retail airport-newsstand business, for a long, long time," says Cohen.

Isaac Cohen, James Cohen's grandfather, started The Bayonne News Co., a distributor for the William Randolph Hearst-run New York

Evening Journal, in 1918. Eight years later the distributor became incorporated as the Hudson County News Co. The company began selling magazines after World War II and opened its first retail location at the then-Newark Liberty International Airport in the late 1970s.

But the retail business really didn't pick up steam until 1987 when Hudson unveiled a branded store at LaGuardia Airport with "modern styling and [an] increased number of [magazine] titles," says Cohen. Hudson sells almost 1,000 such titles in varying genres from its network of wholesales suppliers.

Since the distribution business is mature, Hudson's growth in that division comes most-

ly from acquisitions, says Cohen. However, the retail unit "generates its own internal growth," for the most part because the U.S. airport market is "huge," he says. The company has stores in three Canadian airports but has no immediate plans to expand overseas.

If they do head to other foreign soil, Robert Cohen, James Cohen's father, might be leading the charge. The 81-year-old Hudson chairman still "comes in every day. He never fails to make some suggestions and critiques. He's got quite a lot of experience so we usually listen to him," says the younger Cohen. ◆

Squeezing the Profits out of Fruit

CLEMENT PAPPAS & CO., family-owned and operated since 1921, is a juice bottler that makes sure it keeps evolving with changes in consumer demand.

Sixty years ago, it was canning local produce. Today fruit juices that are labeled as store brands make up 90% of the company's sales, says Peter Pappas, president and COO of the Seabrook-

based beverage bottler. "As retailers have concentrated and become larger, they want to brand their stores and they find they can do that effectively by providing their own corporate brands to customers at good value prices," says Pappas. "The chain stores can drive a little higher [profit] margin selling their own
